1. The Contest Judging System uses either anonymous judging process or on-spot panel judging process. ICS staff, contestants and their immediate families are prohibited to influence judging process. Violator will be barred from the contest.

3. The contestant has a one time request of an appeal of the decision of the contest judge. The written appeal will be reviewed by the Appeal Review Panel. The written appeal result will be sent to the contestant within 2 weeks from when the appeal request was received by ICS. Appeal Decision of Contest Judge is final and binding on all entrants. After the appeal review, any new contest results will be published and announced as in (2.).
4. Participation in the Contest constitutes acceptance and agreement to the Contest Rules.
